

AWARDS OF ISPPD 2024-25

Nominations/applications are invited from the ISPPD members of good standing for the following awards for the year 2024-25.

1. Fellow of ISPPD
2. Star Pedodontist Award
3. Young Pedodontist Award
4. Dr. Latha Anandakrishna Memorial Award (**only for post graduates**)

Eligibility-

1. **Fellow of ISPPD** is the highest honour to the senior members of ISPPD who have-
 - (i) Membership of ISPPD for at least 20 years with atleast 15 publications in PubMed/Scopus indexed Journals (minimum 5 international) and at least 5 as first author to his/her credit and other major contributions to the Society.
 - (ii) Attended minimum 10 conferences/conventions.

The award would be in the form of a certificate and a plaque. The nomination for the award can be made on the prescribed format through the Head of the Department imparting Postgraduate Training in the specialty of Pedodontics (Pediatric) & Preventive Dentistry or by a member of ISPPD with good standing with at least 15 years of continuous membership. Only 2 awards can be given in a year.

2. **Star Pedodontist Award** is given to a life member of the Indian Society of Pedodontics (Pediatric) & Preventive Dentistry of good standing and a teacher who has completed service for a minimum period of **1 year as the Principal/Dean** or any other equivalent post in a recognized academic institution/college. He/She must have attended at least 5 conferences/conventions of ISPPD.

3. **Young Pedodontist Award**

This award is for young Pedodontist (Pediatric Dentist) under 35 years of age who is a life member of ISPPD with good standing and has-

- (i) Attended minimum 3 conferences/conventions as life member.
- (ii) At least five paper presentations at national/international level.
- (iii) Minimum five publication (preferably in PubMed/Scopus indexed Journals & 2 as first author)
- (iv) The award will be given to the individual who has more achievements and has substantially contributed to the society. Annually only one award would be given.

Award committee will select the eligible candidate out of the total number of nominations. The decision of the award committee will be final.

4. **Dr. Latha Anandakrishna Memorial Award**

(only for Post Graduate students)

Given to for a Postgraduate with the highest number of Good Quality Publications


- A Post Graduate(I / II / III MDS), who is Pursuing his/her Specialization in the subject of Pediatric and Preventive Dentistry in an institute established and recognized under the laws anywhere across INDIA can apply for this award, duly endorsed by the Head of the Department.
- A postgraduate must be a student member of The Indian Society of Pedodontics and Preventive Dentistry (ISPPD).
- The published article should be the work carried out during his / her period of post graduation and endorsed by the respective Head of the Department.

Selection Criteria

- Only **ONE** award will be given per year.
- The Award will be presented at the **ISPPD Annual Conference** every year to the winner who is a **POST GRADUATE STUDENT**(Life members are not eligible for the award)
(A Post Graduate is one, who is pursuing his/her specialization in the subject of Pediatric and Preventive Dentistry in an institute established and recognized under the laws any where across INDIA).
- A post-graduate student is eligible to apply for the award **ONLY ONCE** during his/her post-graduation period.
- The applicant must be a member of The Indian Society of Pedodontics and Preventive Dentistry (ISPPD)

- **Period:**
 - Articles must have been published before the last date of submission.
 - If there is a tie between two or more submissions, the publication with **the highest impact factor** will be chosen. Impact factor to be decided, based on Clarivate analytics followed by Scimago
 - If the impact factor is not, or cannot be stated, **indexing** will be considered in the order of Clarivate analytics (WOS), PubMed, Scopus, followed by others.
- While evaluating publications for an award, the preference will be given in the following order
 - (i) **A systematic review**
 - (ii) **Original research**
 - (iii) **Letter to the editor**
 - (iv) **Narrative review**
 - (v) **Case report, and last**
 - (vi) **Guest Editorial.**
- If more than one postgraduate student contributed to a single publication as authors, the award shall go to the postgraduate student with higher order of authorship.
- If **no entries** are received with post-graduate students listed as the first author, the second or third, or fourth author should be taken into consideration, and **rest all the above criteria would remain the same.**
