- (iii) To contest for any of the posts, the life member must have <u>attended at least 3 out of</u> the last 5 AGBMs of the Society (Certificate can be obtained by the H.O. & to be submitted with the application).
- (iv) To contest for any of the Honorary office bearer's posts (<u>President Elect</u>, Secretary General, <u>Vice President</u> & Editor in Chief) the candidate should have <u>served at least 2 terms as an Executive Council member and completed one full term as one of the nominated office bearers</u> (joint/assistant secretary, assistant treasurer, associate/assistant editor).
- (v) Any member would be considered to have completed his/her one year term in Executive Council only if he/she attends 3/5 to 4/5 (60% to 80%) of the total EC meetings conducted in that year. Out of the 5 EC meeting in a year, a member must have attended at least one of the two EC meetings conducted outside the conference and convention venues.
