- (iii) To contest for any of the posts, the life member must have <u>attended at least 3 out of the last 5 AGBMs of the Society</u> (Certificate can be obtained by the H.O. & to be submitted with the application).
- (iv) Any member would be considered to have completed his/her one year term in Executive Council only if he/she attends 3/5 to 4/5 (60% to 80%) of the total EC meetings conducted in that year. Out of the 5 EC meetings in a year, a member must have attended at least one of the two EC meetings conducted outside the conference and convention venues. Any member of the Executive Council (including the office bearers) who is absent for three consecutive EC meetings or more than half of the meetings held during his/her term of the Executive Council shall cease to be a member of the Executive Council. Such a member shall not be eligible for re-election/renomination to the Executive in the next term.
- (v) If any member while serving in EC or in any office bearer post is found to violate the Constitutional By-Laws, then it will render him/her ineligible to continue his/her term in that post and file nominations for any post in the future for a minimum period of 5 years.
- (vi) No members can file nominations for the same post for more than 2 consecutive terms. A lapse of one term is mandatory for applying for the same post including the EC member's post.
- (vii) To re-apply in the Executive Council, a member must have attended minimum 3/5 EC meetings held last year, out of which one meeting attended must be out of the conference/convention venue.


