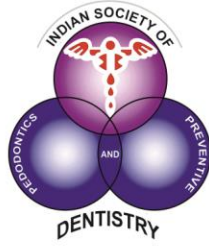

Minutes of the IIIrd EC Meeting at Chennai, 23rd February 2023.

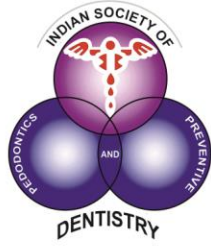

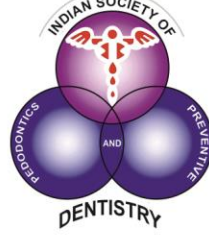
