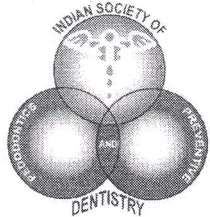

Agenda -1 Confirmation of the minutes of 4th EC Meeting

Agenda -2 Confirmations of Secretary's Report:
